 - D. Also advised to contact Pete Adams of LDAA to get feedback for input on the Veterans Court.

- III. Report of the Statutory Revisions Committee, Workgroup 2:Release Mechanisms – Honorable Fredericka Wicker, Committee Chair
 - A. The Workgroup has met three times and continues to add advisory members to represent all areas of law enforcement.
 - B. Mission Statement has been adopted.
 - C. Short Term Priorities Identified:
 - i. Geriatric Releases
 - ii. Release on Parole 2/3 on a 2nd and 1//2 on a 3rd.

- iii. Moving the infirm and terminally ill from DOC custody to secure nursing homes that can provide medical supervision while they remain on parole.

 - iii. Probation and Parole Case Management System

- VI. Report on Pew Charitable Trust - Mr. Richard Jerome
 - A. The letter requesting technical assistance was received and a response will be forth coming.
 - i. The breadth of signatures on the letter and the participants at the August 12 meeting demonstrated support of all parties in Louisiana.
 - ii. Currently working with 9 other states working on Sentencing Restructuring.
 - iii. Pew works with Sentencing Commissions, task force, state officials, governors' office and others to provide technical assistance and national experts on various topics.

VIII. Other Business

- A. Question raised by June Behrens (guest) on multiple Offender Bill and how the data impacts inmates total sentence. A brief discussion ensued.
- B. Chairman Babin encouraged members to contact other members that have not been active to nominate a proxy.
- C. The next report of the Louisiana Sentencing Commission to the Governor and Legislature is due March 1st, 2012; however, the Commission plans to issue an interim report to the legislature for the 2011 Regular Session in order to provide an update of the Sentencing Commissions activities and to make any necessary recommendations.
 - i. Representative Lopinto reminded the group that the 2011 Regular Session is a fiscal session, which limits the number of general bills each legislator is allowed to five.
 - ii. He encouraged drafting legislative proposals as soon as possible to allow legislators ample time to consider any recommendations by the Commission.
- D. January 31 will be the Commissions deadline for drafts of legislation.
- E. Chairman Babin recognized Cloyce Clark attending the meeting on behalf of the Governor's Office.
